## MERCHANT APPRENTICESHIP PROFESSIONAL INSTITUTE TERMS AND CONDITIONS FOR MERCHANT AFFILIATE

Welcome to the **World of BAPI!** You are now associated with one of the fastest growing companies in the United States today. In addition to that, you are now involved in one of the most unique industries ever—Apprenticeship Business Services. As a Merchant Affiliate, you are a vital link to the BAPI Plan of Influence and your benefits will always reflect your efforts. Below, we have described TERMS AND CONDITIONS governing your BAPI Merchant partnership operation. The Ts&Cs address the following areas:

- 1. GENERAL COVENANT
- 2. TERMS OF OPERATION

### GENERAL COVENANT

The Merchant Affiliate must sign and adhere to the agreement of which this document and its appendices are an attachment. The signed agreement must be filed with BAPI WITHIN 30 DAYS OF SIGNING.

#### MERCHANT AFFILIATE TERMS AND CONDITIONS

The following Terms and Conditions form the basis of the Merchant Affiliate Agreement.

**Authorization and Contract.** By signing the MERCHANT AFFILIATE agreement, you apply for legal authorization to become a BAPI-affiliated BUSINESS OWNER. You acknowledge that prior to signing you have read and agree to the terms set forth on the agreement.

**Expiration and Renewal.** You must maintain a current authorization in order to preserve your rights as a MERCHANT AFFILIATE, including all rights to market products and services.

Your authorization expires on December 31st each year. To remain a MERCHANT AFFILIATE, you must annually submit prior to December 31<sup>st</sup> your Renewal Agreement along with the required renewal fees. Your renewal may be

processed electronically without any additional signatures from you, thus you agree to remain bound by the terms of your MERCHANT AFFILIATE Registration. Failure to annually renew your authorization on time will result in the loss of your rights as a MERCHANT AFFILIATE. **Independent Contractor Status.** You agree this authorization does not make you an employee, agent, or legal representative of BAPI Inc., your sponsor, or your Mentor MERCHANT AFFILIATE. You will be operating your own independent Merchant. with respect to federal or state tax purposes, and you will be responsible for payment of any self-

employment and other income taxes.

**Availability.** BAPI and the Financial Services Merchant model is only available in any location where high speed internet is accessible.

**Remedies.** You understand that action may be taken against your Independent Merchant up to and including termination if you fail to comply with any terms of this Agreement, including the MERCHANT AFFILIATE agreement set forth,

**Unenforceability** In the event that any term or provision of this Agreement is held to be invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect the remainder of this Agreement, and this Agreement shall be construed and enforced as if the invalid or unenforceable term or provision had never existed. No waiver of any default or breach of any provision of this Agreement, or failure to enforce rights

contained herein, shall operate as or be deemed a waiver of any subsequent default or breach. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one instrument.

**LIABILITY**. BAPI is in no way deemed liable for any illegal actions or actions with malice of forethought taken by the Affiliate while dealing with the general public.

# **TERMS OF OPERATION**

- 1. The Merchant Affiliate must be able to dedicate a total of 10 after work and Week end hours to the BAPI program
- 2. The Merchant Affiliate must successfully complete all 6 weeks of Merchant Affiliate training
- 3. The Merchant Affiliate must maintain a good standing as an Independent Merchant Affiliate of the BAPI.
- 4. The Merchant Affiliate can not be involved in any activity that might present itself as a conflict of interest to those of the BAPI program
- 5. The Merchant Affiliate must be willing to pay the necessary fees to establish and maintain a Merchant offered by the BAPI.
- 6. The Merchant Affiliate's acceptance on the program is contingent upon the successful passing of a background check and drug screen.

- 7. The Merchant Affiliate must maintain a level of professional behavior and relationship with and assume responsibility for the professional development of his/her Business protégés .
- 8. The Merchant Affiliate's business must be generally, morally and ethically in the Christian business community
- 9. the Merchant Affiliate must maintain an ethical reputation as becoming that of a Merchant leader in both his/her personal and professional dealings.
- 10. The Merchant Affiliate must maintain a level of Merchant competence and continuing education as prescribed or required by the BAPI policies and guidelines
- 11. The Merchant Affiliate is paid based upon the current marketing / payment plan of the BAPI
