- **Access to the \$20/month mentoring subscription commission of 6.25% up to 6 -tiers deep**

**MENTORING Affiliate:** A full participating member of the PASSION BUILDERS Community and must purchase the required course and/or books and as such have all the privileges listed below:

- **25% on initial sales of any product or service**
- **6.25% on each tier up to 6 tiers deep**
- **Access to the \$20/month mentoring subscription commission of 6.25% up to 6 -tiers deep**
- **Access to the \$75/month mentoring subscription commission of 6.25% up to 6 -tiers deep**
- **Access to the All Capital Reinvestment benefits**

- **Access to all authorized bonuses rewards**

## **COMPENSATION**

Compensation will be paid to the Registrant during the first & third week of every month based upon the total first level of product & service mark up generated for the previous pay period.

The compensation and payout check is calculated based upon the following parameters.

## **SUBMITTALS**

Prospects

Positive referrals should be provided to the Sponsoring Church/Referral/Mentoring Affiliate through whatever means specified. The Sponsoring Church/Referral/Mentoring Affiliate will approach the referred prospect and present the Marketing Plan. Once the Prospect subscribes to the product or service, the compensation table given above applies.

Each Prospect has the ability to refer other potential prospects who must establish a separate Referral Agreement.

All prospects and customers remain the clients of the Church/Referral/Mentoring Affiliate for the life of this agreement.

## **AGREEMENT**

The Church/Referral/Mentoring Affiliate must sign and adhere to the agreement of which this document and its appendices are an attachment. The signed agreement must be filed with ROPE WITHIN 30 DAYS OF SIGNING.

**CHURCH/REFERRAL/MENTORING AFFILIATE  
TERMS AND CONDITIONS**

The following Terms and Conditions form the basis of the Church/Referral/Mentoring Affiliate Agreement.

Individuals or entities, may apply for authorization to become a ROPE-affiliated CHURCH/REFERRAL/MENTORING AFFILIATE. The individual signing this document must have signing authority for the specified entity

- As used herein, the terms “You” and “Your” shall refer to the individual(s) signing the CHURCH/REFERRAL/MENTORING AFFILIATE Registration Form

**Training** The CHURCH/REFERRAL/MENTORING AFFILIATE agrees to submit to and successfully complete the ROPE training program. Failure to do so may result in the loss the Affiliates rights or privileges under this agreement.

**Authorization and Contract.** By signing the CHURCH/REFERRAL/MENTORING AFFILIATE Registration Form, you apply for legal authorization to become a ROPE-affiliated CHURCH/REFERRAL/MENTORING AFFILIATE. You acknowledge that prior to signing you have read and agree to the terms set forth on the CHURCH/REFERRAL/MENTORING AFFILIATE Registration Form. To become an CHURCH/REFERRAL/MENTORING AFFILIATE, you need only possess the literature portion of the ROPE Registration Materials.

**Expiration and Renewal.** You must maintain a current authorization in order to preserve your rights as an

CHURCH/REFERRAL/MENTORING AFFILIATE, including all rights to your sponsored and registered CHURCH/REFERRAL/MENTORING AFFILIATES, and Clients. Your authorization expires on December 31st each year. To remain an CHURCH/REFERRAL/MENTORING AFFILIATE, you must annually submit prior to December 31<sup>st</sup> your Renewal Agreement along with the required renewal fees. Your renewal may be processed electronically without any additional signatures from you, thus you agree to remain bound by the

terms of your CHURCH/REFERRAL/MENTORING AFFILIATE Registration Failure to annually renew your authorization on time will result in the loss of your rights as an CHURCH/REFERRAL/MENTORING AFFILIATE, including all rights to your sponsored and registered CHURCH/REFERRAL/MENTORING AFFILIATES, and Clients

**Independent Contractor Status.** You agree this authorization does not make you an employee, Affiliate, or legal representative of ROPE LLC., your sponsor, or your Team Leader CHURCH/REFERRAL/MENTORING AFFILIATE. You will be operating your own independent business, buying and selling products and services available through ROPE on your own account. You have complete freedom in determining the number of hours that you will devote to your business, and you have the sole discretion of scheduling such hours. ROPE Inc. will not provide you with a place of business, and if you desire a place of business other than your own residence, you will be responsible for procuring, furnishing, and paying the rental for such place of business. With respect to services performed by you for ROPE Inc., your sponsor, and Team Leader CHURCH/REFERRAL/MENTORING AFFILIATE, you will not be treated as an employee with respect to federal or state tax purposes,

and you will be responsible for payment of any self-employment and other income taxes. You will receive IRS Form 1099-MISC reflecting the amount of income paid to you during the calendar year by ROPE Inc., your sponsor, or your Team Leader CHURCH/REFERRAL/MENTORING AFFILIATE. It will be your sole responsibility to account for such income on your own tax returns.

**Availability.** ROPE and the Financial Services business model is only available in the state of Georgia with plans to expand throughout the Southeast very shortly.

**Remedies.** You understand that action may be taken against your Independent Business up to and including termination if you fail to comply with any terms of this Agreement, including the CHURCH/REFERRAL/MENTORING AFFILIATE Registration Form,

**Unenforceability** In the event that any term or provision of this Agreement is held to be invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect the remainder of this Agreement, and this Agreement shall be construed and enforced as if the invalid or unenforceable term or provision had never existed. No waiver of any default or breach of any provision of this Agreement, or failure to enforce rights contained herein, shall operate as or be deemed a waiver of any subsequent default or breach. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one instrument.

**LIABILITY.** ROPE is in no way deemed liable for any illegal actions or actions with malice of forethought taken by the Contractor while dealing with general public.

**CONFLICT OF INTEREST.** Contractor agrees not to engage in activity that is in direct conflict to the activity required to perform the responsibility assigned or any activity which might divert business to ROPE's competitors.

**NON-SOLICITATION.** Contractor agrees not to solicit ROPE's mutually acquired customer base for 6 (six) months after termination of this contract.

## **TERMS OF OPERATION**

1. The Church/Referral/Mentoring Affiliate should be able to dedicate a total of 4 after work and Week end hours to the ROPE program
2. The Church/Referral/Mentoring Affiliate must successfully complete all 6 weeks of Church/Referral/Mentoring Affiliate training
3. The Church/Referral/Mentoring Affiliate if chosen must maintain a good standing as an Independent Business Owner of the supplying company.(ROPE)
4. The Church/Referral/Mentoring Affiliate can not be involved in any activity that might present itself as a conflict of interest to those of the ROPE program

5. The Church/Referral/Mentoring Affiliate If chosen must be willing to pay the necessary fees to establish and maintain a business offered by the supplying company.
6. The Church/Referral/Mentoring Affiliate's acceptance on the program is contingent upon the successful passing of a background check and drug screen.
7. The Church/Referral/Mentoring Affiliate must maintain a level of professional behavior and relationship with and assume responsibility for the professional development of his/her protégés .
8. the Church/Referral/Mentoring Affiliate must maintain an ethical reputation as becoming that of a business leader in both his/her personal and professional dealings.
9. The Church/Referral/Mentoring Affiliate must maintain a level of business competence and continuing education as prescribed or required by the ROPE policies and guidelines
10. The Church/Referral/Mentoring Affiliate is paid based upon the current marketing / payment plan of ROPE or the supplying company
11. The Church/Referral/Mentoring Affiliate is responsible for meeting all local , state and federal tax obligations.
